PRAIRIE UNITARIAN UNIVERSALIST SOCIETY FALL 2005 PARISH MEETING MINUTES NOVEMBER 20, 2005

Meeting called to order at 11:50 am 43 members present

MINUTES

Minutes of the 2005 Spring Parish meeting and this meeting's agenda were distributed.

TREASURER's REPORT—Dirk Herr-Hoyman

Reports distributed. (See attached.) Pledges are on target for 2005. New expenses are minister, roof, and the sound system.

There has been a change in assets' assignment in this report. To finance the land acquisition for the new building, CD's have been cashed and the mortgage has been refinanced. The balance for 2004 was \$62,000 and now is \$20,000 so cushion is more limited. The mortgage payment is the same. The land was purchased for \$305,000 and loans from Prairie members total \$225,000. The remaining portion was covered by loan.

MOTION: Treasurer's report accepted (Rosemary Dorney, Anne Urbanski). Passed unanimously.

MINISTER'S REPORT—Rev. Jody Whelden

Jody reviewed her five charges which include: Work with the Caring Committee, Attract new members to Prairie, especially families with children, Work with Long Range Planning to envision a new future and emphasize commonality of values, Work with Committee on Ministry which provides support and direction to the ministry, and Work with the Right Relations committee to develop a covenant of right relations among ourselves.

FINANCE—Norma Briggs and Steve Vorass

- 1) The proposed 2006 budget was distributed (see attached) and was presented as a "bare-bones" budget. Some changes have been made including deletion of unspent line items, and also separating out expenses such that RE has their own budget and the minister has her own, as examples. Note was made that we now have three quarter-time paid staff and that heating expenses are expected to rise 45%. Fewer funds were allotted for Lay Ministries now that we have a ¼ time minister. It was explained that "Fair Share" for UUA amounts to \$66 per member. Ten new pledges have been made. It was made clear that the land purchase is reviewed in a separate document and not included in this operating budget. Sharrei Shamayim will be asked to increase the rent paid per year by \$750 (from \$6000). No capital expenditures are included in that the roof and sump were arranged for in the previous budget. Plans for a fence and modernizing the RE kitchen were deleted. Cost for phone and internet service provider were consolidated.
- 2) The land purchase in Fitchburg was then reviewed. Those who loaned Prairie would receive 3% per year for the first 3 years, and 5% thereafter. The refinancing of our Whenona church building resulted in the same monthly payments for a longer period of time.

P2, Fall 2005 Parish Meeting Minutes.

Comments re: Finance report included:

- --A recommendation that any overage be applied to capital reserves for contingencies.
- --A priority should be made to use funds to increase publicity to increase membership.
- --Regret expressed that \$1000 for delegates to the UUA General Assembly was deleted.
- --Another member felt that more energy should go to RE and taking care of new members.

MOTION: 2006 Budget adopted as presented. (Larry Nahlik, Aileen Nettleton) Passed unanimously.

Discussion then ensued as to the role of the congregation in proceeding with financing a new building. It was felt that a clear plan be presented after a realistic assessment made of our financial situation. Support was given to borrowing funds if there is a reasonable expectation that the loan can be repaid.

MOTION: The congregation is to be consulted if major decisions re: financing a new building are involved. (Bob Park, Mike Briggs) Passed unanimously.

COMMITTEE REPORTS

Written copies of committee reports will be made available to the congregation.

MOTION: MINUTES from Spring Parish 2005 meeting were approved as distributed. (Judy Skog, Dirk Herr-Hoyman)
